## ***GOVERNOR'S MESSAGE ...***

### **Highs, Lows, and Get-Over-Its**

Here in D12, we had some great Area Meetings—thanks to the planning of the Cheyenne, Boulder, Royal Gorge and Spearfish Clubs, and our dynamic Area Directors. This ‘communication thing’ really works in that we usually come away re-invigorated by the creativity and dedication of the Zontians we meet there. I hope you, too, shared in this ‘High’.

Then, we get to membership renewal time (May), and it is a difficult time for Zonta Clubs. There are always non-renewals, and it feels like one is losing good friends and the strength of the ‘family unit.’ What a bummer!! (OK ... I’ll save my moaning for some other day!) Where a circle of hands will open to receive us; eyes will light up as we enter, voices will celebrate us whenever we come into our own power. *Community means strength that joins our strength to do the work that needs to be done.* Arms to hold us when we falter. A circle of healing. A circle of friends. Where we can be free.

## **AREA 2 MEETING—APRIL 1-2, 2011—CHEYENNE**

The 2011 Area 2 meeting began with an informal social dinner at Suite 1901, appropriately a “tapas” bistro in Cheyenne since the theme for the event was “Zonta is International.”

The Zonta Club of Cheyenne was the host for the Area 2 meeting which officially began on Saturday, April 2, at the Historic Plains Hotel with 28 Zontians in attendance. The welcoming remarks were extended by Club President Michelle Ammerman, Area 2 Director Mary Walker, and Vice Area 2 Director Heidi Lukowski.

Denise Parrish gave the keynote address, “A Wyoming Zontian’s Work on Infrastructure in Developing Nations.” Denise has traveled extensively as an advisor, helping emerging countries with their plans for energy delivery, communications, urbanization, education. Her work has taken her to many international destinations including the former Soviet republics as well as many countries in sub-Saharan Africa. She sees firsthand the challenges confronting women as their communities struggle with globalization and modernization.

The remainder of the morning session included remarks by Governor Kay Meyer, Lt. Gov Sheila Davis, District Committee Chairs, the Zonta Foundation Ambassador, and the District UN Chairman.

For many, the highlight of the meeting followed lunch. The subject for the Area 2 Clubs panel was “Biggest Achievements and Biggest Challenges.” This was a stimulating, interactive discussion period that produced concrete suggestions and plans to be pursued by the members who attended. As we said, “Good-bye” it was with a renewed commitment to Zonta and an increased sense of camaraderie that is the primary benefit of Area meetings.

## **AREA 3 MEETING—APRIL 9, 2011—BOULDER**

Domestic violence is not a problem just for adults. Teens experience domestic violence in their relationships too. In fact, one in three teens experience some kind of abuse in their relationships. Some 40% of teenage girls, ages 14 to 17, know someone their age who has been hit or beaten by their partner.

I didn’t know this! Did you? The Area 3 meeting, hosted by the Zonta Club of Boulder County, was held on April 9, 2011, at The Stratford at Flatirons in Broomfield. Featuring a program called “In Their Shoes – Teens and Dating Violence,” attendees learned what it is, how do I recognize it, and what can I do about it?

Kathy Robertson, host committee member and founder of Abby’s Voice, set the stage by discussing the problem and her personal experience of losing her daughter to teen date violence. A panel of experts from many fields that touch teen domestic violence was assembled to discuss the topic. Panel members included: Victoria Lucero - Detective, Longmont Police Department; Jenny McDonald - Law Student, University of Colorado at Boulder; Barb McGraw - Teacher, Angevine Middle School; Debra Thornton - Victims Advocate, Glendale Police Department; Sam Cole - Center of Domestic Violence, University of Colorado

After an introduction of the panelists and the discussion of the problem in their specific area, the questions were opened up to the audience. For an hour, the audience was very engaged, and asked questions, such as:

“What signs do I look for that indicate a problem?” “As a mother/grandmother, how do I raise this topic with my daughter/granddaughter?” “How does social media contribute to the issue?” “What can I do from a legal standpoint?”

Following a discussion of many questions from a very active audience, Victoria Lucero and a student from St. Vrain School District demonstrated the training they perform in the School District. This training, designed to assist in helping students recognize teen dating violence, was well received.

During Zonta Business, Kay Meyer, Governor, provided an update of the current biennium and progress toward our goals. Sheila Davis, Lt. Governor, discussed membership goals and challenges, and Nikki Headlee, ZIF Ambassador, talked about the wonderful Zonta International Service Projects and progress toward the Zonta International Foundation fundraising goals.

Our featured speaker during lunch was Megan Pratt from Project Safeguard. Megan spoke about Project Safeguard, its function and role and how it is just starting to get more involved in teen dating violence.

The final area was “What can I do about it? / What can “we,” as Zontians, do about it? Kathy Robertson lead a discussion of what each member could do, which included:

1. Signing a petition to advocate getting training in schools across Colorado. Kathy Robertson is leading this effort, which is taking time, but continues the focus.
  2. Writing a letter to their state senator and legislator advocating for training in schools, and
  3. Writing a letter to the local school, suggesting training such as that provided in the St. Vrain School District.
- Overall, the feedback was very positive!

## **AREA 4 MEETING—APRIL 16, 2011—ROYAL GORGE**

### **Over the Edge by Pat Meyer**

“Do not fear risk. All exploration, all growth is calculated. Without challenge people cannot reach their higher selves. Only if we are willing to walk over the edge can we become winners.”—from *Call to 2011 Area 4 Meeting*

As we approached the Bighorn Mountaintop Lodge, we were immediately struck by the symbolism that obviously inspired the theme “Over the Edge.” The lodge, built on the precarious edge of the Royal Gorge, created the setting for a breathtaking view of the river cutting through the gorge and the bridge overlooking it. Following a continental breakfast and raffle sales for baskets and wine brought by each of the Area clubs to raise money for the District 12 Scholarship Fund, Sharon Brookins, from the host club, Royal Gorge, welcomed us to the 2011 Area 4 Meeting and introduced the speakers.

Sheila Davis, District 12 Lt. Governor opened the program with remarks for both herself and Kay Meyer, District 12 Governor (who was at home with back spasms). As stand-in for Governor Kay, she requested feedback on whether the District was meeting the needs of the individual clubs and what concerns or suggestions the individual clubs had for the District. As head of the D12 OMC Committee, she offered suggestions for recruiting and retaining members and reported on progress in creating new clubs in Pueblo and Greeley. Next, each club shared their best ideas and greatest challenges. Interestingly, the successes & challenges were in the same areas: fundraising, membership recruitment and retention. Then Foundation Ambassador Nikki Headlee and D12 UN Co-Chair Mary Lou Edwards helped us better understand how the service funds we donate to Zonta International (ZI) are used by showing a short video on ZI’s 2010-2012 service projects.

Dave Bergin, Pueblo Deputy District Attorney and former bill drafter for the Colorado Legislature, spoke about the process of forming state legislation. In both the House and Senate, a bill follows the same steps: 1<sup>st</sup> introduced and read in committee, 2<sup>nd</sup> reading with committee debate and amendment, and 3<sup>rd</sup> reading + vote to send to the whole body (H or S). It is helpful to our advocacy efforts to understand this process and use it to follow a bill we want to support.

The final speaker, Crystal Jonas, 9X published author, held us all spellbound with advice on how to attract others to the Zonta cause by building confidence in ourselves and our ability to move others to action. This can be accomplished, she said, by respecting and listening to others, then showing them how participation in our cause will benefit them. She laughingly warned us not to tell people that Zonta requires hard work and then expect them to dive in. The universe rewards recognizable results, not hard work, she said, so showing people the results of our efforts is the best way to motivate them to join us.

Our hosts wrapped up the activities by recognizing those attending an area meeting for the first time and thanking the hosts. Laura Stamp, Area 4 Director, presented Janet Bergin and Sharon Brookins with potted columbines in the Zonta colors of mahogany and yellow.

As I walked out and looked “over the edge” with my Zonta sisters, I felt more like a winner and more ready to work for results. The meeting had inspired me.

## **AREA 1 MEETING—APRIL 29-30, 2011—SPEARFISH**

The Holiday Inn of the Northern Black Hills in Spearfish was the site of the Area 1 Meeting on April 29-30, 2011 with the theme, “Strength From Our History, A Future Without Limits.” The host Spearfish Club shared hors d’ouevres (and the Sturgis Club provided dessert) for 23 attendees at the High Plains Western Heritage Center on Friday evening. Attendees casually toured the facility, which has an amazing collection of life in the “Old West,” and caught up with “old” friends.

Saturday morning’s welcome was made by Sue Konstant, President of the Zonta Club of Spearfish. Jo Prang, Area 1 Director, then facilitated the Zonta business session. Governor Kay Meyer presented a summary of the current Zonta Biennium. Lt. Governor Sheila Davis reported on D12’s OMC progress toward the goal of 711 by the end of the biennium; we currently have 615 paid members according to Anita Zastrow, Internal Communications Chairman. Additional brief reports were made on behalf of D12 committee chairmen unable to attend.

During the Club Sharing Time, current Presidents shared similar themes for their “Best Successes” and their “Biggest Challenges.” Major fundraisers were the best successes while the biggest challenges were trouble with meeting places and lunches, etc.

Two speakers were thought provoking and informative. First, Laura Colmenero-Chilberg, PhD, from the Department of History and Social Science at BHSU gave a fascinating history of the “Women’s Club Movement and the Spearfish Women’s Club.” Interestingly enough, Zonta’s founding “mothers” got many things exactly right! #1. The Mission—helping empower women less fortunate than themselves. #2. The Diversity—providing the clubs with strength and creativity. #3. The Professionalism—giving clubs the competitive edge to survive and grow. #4. The Advocacy—currently re-emphasizing and

learning to do better in our new age of communication. From Laura's "walk through the past," we realized that right now we are fortunate that "Global is IN," that technology has made it easier to communicate, and that affecting the "status of women" influences entire societies worldwide. In other words, Zonta needs to get the message out by increasing our visibility in our communities, increasing our membership, having meetings and programs with good, relevant content, and focusing on issues affecting women's advancement. TELL OUR STORY!

Second, Nyla Griffith, co-founder of TDG Communications in Deadwood and the Executive Director of the Northern Alliance for Children, spoke on "Limitless Strength Without Eccentricity, Charging the Line Without Ever Leaving the Circle." She talked about being well-rounded, not letting life change the shape of our circle into an "eccentric" circle which will not roll like a wheel. After all, only the roundest of circles keeps moving forward. [She demonstrated this with two distinctly different wheels.] Nyla definitely demonstrates her "circle" attitude in the accomplishments she has made. We learned that against many odds, she spearheaded a project in Deadwood that now takes care of the children of Casino workers, who previously may have had few or no options for childcare. Some children were reportedly sleeping in their parent's car while moms were working late into the evening. The new state-of-the-art facility for children in Deadwood has top-notch security, teachers on staff, and has several prominent citizens on its board of directors. We applauded Nyla's efforts and realized the power of an idea can be accomplished when the right group of people come together. Zonta has a BRIGHT FUTURE!

Finally, roundtable discussions were held about what could we do as Zontians to meet and beat our "Greatest Challenges." The results will be shared at the District Conference in September in Rapid City!

The Women's Higher Entrepreneurship Learning Program (HELP) is a resource center website that offers virtual training and regional networking to facilitate and support entrepreneurship and micro enterprise development for women. This creative and innovative training program in business development is created by an excellent advising and academic committee from Leeds School of Business and Deming Center of Entrepreneurship at the University of Colorado at Boulder.

This program has three levels with six courses in each level: Entrepreneurship, Entrepreneurial Marketing, Bookkeeping & Accounting, Financing New Ventures, Team Building and E-Commerce (E-Commerce has only two levels). The students have three months to complete the program. A common theme across all topics will be the need and benefit of bootstrapping a business start-up, where financing, marketing, accounting, and production are started with minimum resources. These courses will provide excellent academic and technical knowledge, negotiation skills, and the networking capability to start and develop new businesses.

Program registration is open to the public and is free of charge. Upon completion of all the courses and required assignments, the successful students will receive a certificate of completion from the Deming Center, Leeds School of Business at University of Colorado at Boulder.

## JMK Deadline Fast Approaching—

The July 1 deadline for submission of your Club's Jane M. Klausman Women in Business (JMK) Scholarship recipient is fast approaching!

The Zonta International Foundation established the Jane M. Klausman Women in Business Scholarship in 1998 from a generous bequest from Jane M. Klausman, a member of the Zonta Club of Syracuse, New York, and the 1990-1995 ZI Parliamentarian. The JMK Women in Business Scholarship is awarded annually to women pursuing Undergraduate or Master's degrees in business management.

The program operates at the Zonta Club, District and International levels. Zonta Clubs provide awards for their Club recipients. Zonta International awards scholarships of \$1,000 each at the District level followed by twelve International scholarships in the amount of \$5,000 each. Last year some 26 women from 15 countries competed in the final round of judging for the 12 \$5,000 (US) scholarships.

The updated application and related materials are on the ZI website. Please note that the application has changed somewhat so be certain to use the 2011 Application Form. Also, remember that applicants are responsible for securing their own recommendations. Further, the ZI Board has also decided that the criteria for the Jane M Klausman Award (and Young Women in Public Affairs Award) be amended to include the requirement that candidates need to be "living or studying in a Zonta district/region."

As we begin the 2011 recruitment process, please remember to access the ZI Website at [www.zonta.org](http://www.zonta.org) and/or contact me if you have any questions regarding the 2011 application form, the application requirements, and the application deadline.

**ELIGIBILITY:** Women pursuing a business or business-related degree who demonstrate outstanding potential in the field are eligible. Online students are also eligible. In undergraduate degree's, recipients must be entering the third or fourth year of an undergraduate degree program. Bachelor's degrees that fall into this program are typically, (but not limited to): business administration, accounting, finance, economics, entrepreneurship, marketing, international business, human resource management, management, business education. Master's degrees may include (but not limited to): business administration (MBA), finance, international business and accounting.

**APPLICATION PROCESS:** Applicants must be nominated by a local Zonta Club. Applications can be downloaded from the Zonta International website at [www.zonta.org](http://www.zonta.org) under Member Resources-International Scholarships and Awards where invaluable information to assist your club with advertising and selecting club winners is also included.

**DEADLINES:** Applicants must complete and present the application to Zonta clubs according to the Club's assigned deadline. A Club winner is selected and the application is presented by July 1 to the District JMK Scholarship Chairman. The District winner is presented to the District Governor for submission to Zonta International Headquarters by September 1. International recipients will be contacted by their Zonta Club leadership by mid-October.

Women have made great strides in the pursuit of education, careers and leadership roles they were once denied; however, today, women are still more likely to be pouring coffee in global boardrooms than sitting on the boards. In 2009 women held only 15.2% of the board seats at Fortune 500 companies. The Jane M. Klausman Women in Business Scholarship program helps women pursue undergraduate and Master's degrees in business management and overcome gender barriers from the classroom to the boardroom.


