

Lori Jean Lewis has been selected as one of 12 Zonta International Recipients for the 2013 Jane M. Klausman Women in Business Scholarship. Lori was selected from a field of 31 women from 20 countries that competed in the final round of judging by the International JMK Scholarship Committee.

In July, Lori was selected as the District 12 winner. Lori Lewis is a senior at the University of Wyoming majoring in accounting. Her application was submitted by the Zonta Club of Laramie.

The panel of District 12 judges made the decision from a group of 7 highly qualified applicants submitted by clubs in District 12. The panel was made up of representatives from each area.

Dear Governor Davis,

It is with a grateful heart that I write this letter to express my deepest gratitude for selecting me as the District 12 Jane M. Klausman Scholarship winner.

I had the pleasure of attending the local Laramie, Wyoming Zonta Club in September. The purpose of my visit was to meet and thank the women who had selected me as the local JMK Scholarship winner. More than sharing my own story, I was able to hear the stories of half-a-dozen or more women who were blessed by the generosity of Laramie's Zontians. Until that evening, I had no idea the impact that Zonta had on our community, let alone the world.

Several of the stories I heard that evening brought tears to my eyes. A young woman told of her experience being rejected by her peers as a teenager. She now leads a Big Brothers/Big Sisters group that promotes self-esteem among teenage girls; she has used her unfortunate past to inspire and encourage others. Laramie Zonta

helps sponsor her after-school group. The director of a GED program at a local community college shared that because of Laramie Zonta's financial support a young woman struggling to support a family on her own completed her GED and is now pursuing a nursing degree. Another courageous young woman reported that she recently graduated from CLIMB Wyoming, a program designed to assist single, uneducated mothers. She no longer has to work the graveyard shift as a bartender to support herself and her two children. Each of these women is living proof of the impact that Zonta has on improving women's lives.

I learned a lot that evening about Zonta, and I was overwhelmed by the impact they have had in my community. The women who shared their success stories that evening have overcome so much more than I can imagine. They inspired me to work harder with the gifts I've been given and to not take the blessings in my life for granted. The members of Laramie Zonta reminded me of the tremendous responsibility I have as a woman, a wife and a mother to pay forward the generosity that others have shown to me. No one in that room that evening got to where they were in life without the love and support of other people. More specifically, we each have benefitted from the example and encouragement of another woman – whether mother, sister, mentor or friend.

I am determined to emulate the example that Zontians have set in my community and around the world. Most directly, I am the primary example to my daughter of what a woman can do and be. I want to teach her to work hard to achieve her dreams and goals. I also want her to have a heart of grace and generosity. Indirectly, I interact with women from myriad walks of life in a variety of environments. Whether I have the privilege of knowing them personally or only in passing, I aim to speak encouragement and edification.

I look forward to meeting you in December. Thank you for your generosity. More so, thank you for your example.

The Zonta Club of Laramie is very proud to sponsor the newly formed Laramie High School Z Club, which began in earnest this August. Last fall, new Zontian Tamara Bretting, a chemistry teacher at LHS, expressed her desire to re-establish a Z Club at the high school. She recruited her friend, Jennica Fournier, to join Zonta. Jennica teaches biology at Laramie High School. Together, this awesome duo began laying the groundwork with both students and school administrators to bring the Z Club back into existence after a lapse of several years.

In August, the club held a Welcome Party to introduce parents, friends and officers to the members of the Zonta Club of Laramie. That was quickly followed by Club Rush at the high school. Today, the Z Club has 20+ members and has already completed several service projects in the community -- including cleaning and painting the offices of Interfaith Good Samaritan, a non-profit in the Laramie community that assists families and individuals in need of a helping hand. The Z Club raised the money to purchase the paint and cleaning supplies by conducting a clothing drive at the high school and selling the items on consignment through a local second-hand store.

The Z Club is very active within the school and currently is collaborating with the New Z's of the Zonta Club of Laramie to co-host a self defense class for women and girls in November. The Z Club will promote the program throughout the high school. Stay tuned for upcoming Z Club events or find the club on Facebook.

Bright and early June 14th Sheila Davis, Governor and member of the Zonta Club of Denver, Kay Meyer, Past Governor and member of the Zonta Club of Boulder Foothills, Betty Edwards, Past Governor and member of the Zonta Club of the Pikes Peak Area and I ventured off to Niagara Falls, Ontario for the Zonta North American Inter District Meeting. After an early morning flight, storm delays, and normal travel hassles we arrived at the Buffalo International Airport. While waiting in line for our rental car I spotted the Buffalo newspaper. We all know human trafficking is everywhere, but little did we know that we would be met with such a headline and billboard as pictured above. It was just in time for the arrival of Zontians and it was amazing. We bought all of the papers and shared with others at the conference.

Betty and I stayed Monday for some rest and relaxation. We had a motel booked close to the Buffalo airport for that night and an early Tuesday morning flight. On our way to Buffalo and just after we crossed into the US, Betty broke the news to me that she wanted to see the human trafficking billboard up close and personal. Now the only map we had was the very small Avis Rental Car map of Buffalo. With a lot of urging and perseverance, mostly on Betty's part, we actually found the billboard without getting lost. It was in a semi-industrial part of town perched on the top of an auto detailing business. The owner of the business, a very tall and muscular African-American man, became quite curious when we started to take pictures of the billboard. He came out to talk to us. This was a golden opportunity for Betty to do what she does best—talk about human trafficking. As the founder of the Southern Colorado Human Trafficking Task Force, this is her passion. She is not only passionate, she is knowledgeable. We asked the business owner if he was given any information about human trafficking when the billboard was erected. He wasn't, so Betty took care of that situation by giving him a brochure, information and a stack of the small tri-folds with the 800# emergency number for any suspected trafficking situation. Betty asked what he knew about human trafficking and his answer, "Well, you would have to be pretty stupid not to realize something is going on when people just disappear," was a very to-the-point answer by an average citizen who got caught up by something he had no control of.

Zonta District 12 Education Fund

Formerly known as: Zonta Action Plan (ZAP)

Throughout the years, District 12 has provided training to Zontians through various means. In the past, training was presented through the Zonta Action Plan (ZAP) program, at Area Meetings, and at District Conferences. Currently training is being provided through the new Leadership Training program, at Area Meetings, and through five classes given at this year's District Conference.

As part of yearly dues, the district has been collecting \$2 from each Zontian for education purposes. Now the amount of dollars collected has exceeded the amount spent on training, and currently there is approximately \$8,000 available to use. To facilitate the use of this money, the District 12 Board approved an Education Fund program. The purpose of this program is to provide Area Directors, District 12 Board Members, or others designated by the District 12 Board with funding for the education of Zonta members. The training might include, but is not exclusive to, officer/leadership development, membership recruitment and retention, club revitalization, conflict resolution, and the basic organization of Zonta.

Following is the application process:

An Area Director or other District 12 Board Member may submit a proposal on behalf of themselves or a Zonta club for the training they seek to obtain.

The applicant should provide the following information:

1. The title and subject of the training program.
2. The measurable objective(s) of the program.
3. The means by which the objective(s) will be measured.
4. The number of Zonta members to be trained and from which club(s).
5. The process or plan of the training (how it will be taught/offered).
6. The materials and resources needed for the training with their itemized costs.
7. The total amount of money being requested.
8. Proposed date(s) or timeline and venue.

The proposal should be sent to the District 12 Review Committee Chair, with copies to the Governor and all Area Directors. This will ensure communication between Area Directors who might be able to provide information, resources, and/or insights regarding similar training programs previously attempted or presented. Also, other Area Directors might be interested in having her clubs participate in the training or at least inquire on the outcome of the training program.

Following is the review and approval process:

The Review Committee Chair will forward the proposal & criteria to the Review Committee members. The Review Committee will use the following criteria to select proposals for funding:

- The program will train Zontians and/or Zonta clubs to better meet Zonta International's mission and objects.
- The proposal is in alignment with District 12's biennial goals.
- The proposal makes efficient & effective use of district funds (e.g., appropriateness of actual itemized costs, the number of members to be trained).
- Results of the program are observable and/or measurable.
- Potential exists for further replication/reproduction/packaging of the training.

The committee members shall examine the proposal and submit their reasons for approval to the Chair of the Committee, who shall send her recommendation to the Governor and the District Treasurer. This review process may take place electronically.

If several requests are received which exceed, in total, the available funds, a ranking of applications may be required based on the above mentioned criteria,

the timeliness of each application, and the number of requests already made by that applicant. The total amount of funds available to each area may be limited to the proportion of the total number of clubs in that area in relation to other areas at the time of the request.

The Governor, upon consultation with the District Treasurer, makes the final decision to approve or deny funding. The Governor shall inform the applicant regarding approval, and the Treasurer will allocate a specific line item in the district budget for the program. All expenditures for the program may then be handled in accordance with district procedures for reimbursement. Notification of approval or denial should occur within one month from the time of application submission with the exception of those requests submitted at the end of April of each biennium. Those applications may be delayed to the next biennium to be addressed by the new District 12 Board the following June.
