AREA MEETING REPORTS

Area 1—April 23-24

Zontians of Area 1 met under the watchful eye of Crazy Horse Monument in Custer, South Dakota. The Firday evening social was hosted by the Zonta Club of the Southern Black Hills with members furnishing Hors d' oeuvres. Area 1 members donated items to be auctioned with the evening's profits going to the District scholarship fund. Jeff Storm, Bradeen Auction Service (and husband of Zontian, Teresa Storm) sold items to generous Zontians for a total of \$2,102.50 being raised for the event.

Saturday was spent doing club reports and a follow-up on break oust sessions, similar to those held at the District Conference in Billings. The sessions covered membership, service, fundraising, and nomination process. Part two of leadership training was continued from last year's Area 1 meeting with Virginia Wood Nelson working with members to identify their style of leadership and communication.

Luncheon speaker. Tamara Beach, told Zontians her story of being born in a detention camp in Germany. Her father died before she had an opportunity to know him. Her mother remarried a Russian man from the camp. He was a cruel step father. They all boarded a ship headed for America. Her step father later learned his family was alive in Russia and he could return without retribution. He took Tamara's step sister with him. She and her mother moved to California with other immigrants. Tamara was a latchkey child and found herself doing the cooking and cleaning while her mother worked; she was ten vears old. At age 18, she became an American citizen. Tamara's story was that of women surviving and how she relates Zontains helping women survive. The part of her survival that she is not yet able to share is the death of her only daughter in a traffic accident two years ago. She is working through that grief, and as a strong woman, she will survive.

Our President's Panel, featuring EmmaJo Spiegelberg from Laramie, Mary Walker from Cheyenne, and Bridget Masters from Fort Collins, quickly began to compete with the choir and music from next door. Our meeting was soon relocated to an alternate room in the hotel, and we complimented ourselves for our ability to be flexible when needed!

EmmaJo, Mary, and Bridget shared insights into their

respective club's activities in the areas of service projects, membership recruitment and retention, programs, and fundraisers. As always, the opportunity to share and brainstorm among the Area 2 clubs was well received and exciting, and it provided our members with new ideas to take back to their local clubs.

Our afternoon program consisted of updates from Mary Benoit about the ZAP Institute, Evelyn Haskell about district and international membership issues, Jacki Sammons about the work of the Zonta International Foundation, and Bev Morrow with ongoing information about Z Clubs and Golden Z Clubs. Our afternoon speakers were universally dynamic, informational, and inspiring!

The first attempt for an Area 2 service project was "educational". Members paid an optional \$10 contribution to support the acquisition of sweatsuits and distribution bins. Approximately \$200 was contributed including a \$50 contribution from the Zonta Club of Fort Collins. The project was intended to allow members at the Area 2 meeting to assist with sorting the sweats and filling a bin for each club to take back to their community and donate to the local program of their choice. Given the meeting room relocation, and the extended time allowed for our programs and speakers, the "worker bees" from the Cheyenne club single handedly organized the project themselves and handed the finished distribution bins to the clubs attending. Many thanks to the Cheyenne members who took the initiative to finish this project while the meeting continued!

Approximately eight first-time Area 2 attendees were recognized by Governor Mary and received Zonta District 12 canvas bags.

EmmaJo Spiegelberg "made a difference" by handing out "You Made a Difference!" coins to show her appreciation for those that contributed to the success of this meeting.

The Area 2 meeting also involved a District 12 scholarship raffle. Governor Mary donated an "Amelia Bearhart" bear, and the three clubs in attendance also provided donations, including baskets and a Zonta logo shirt. Approximately \$240 was raised to support the District 12 Scholarship fund.

Spnsored by the Dollywood Foundation, Imagination Library is available to any community with volunteers like us who are willing to work together to give children and their parents the gift of reading. The Boulder Foothills Club received help from the local United Way and together they are having amazing results. Amanda Willis, Regional Director of the Dollywood Foundation, spoke to the group and brought a video made by Dolly Parton explaining why she started this wonderful library. Amanda brought along samples of the books they send to the children. The cost per child per year is only \$27.00, which includes the books and mailing fees. What a wonderful program-we were all inspired!

Attendees were also encouraged to go through their closets to find gently worn evening gowns and party dresses that would benefit high school girls looking for prom gowns. Several organizations in Boulder donated space for a sale in Boulder on April 18 with the gowns costing only \$15.00 each. What a great way to help young girls who would otherwise not have a chance to attend a prom!

Governor Mary Benoit gave a presentation on the ZAP Institute Training which begins in June for all new officers and board members. We also had Lieutenant Governor Evelyn Haskell from Laramie join us, and she gave the members an update on Z-Clubs.

I have so enjoyed working with the members in Area 3 over the past two years. They are an amazing group of hardworking and dedicated women with clubs that continue to grow. I want to thank all of them for their efforts in supporting the goals of Zonta International.

Women in Politics Still Lagging

One of the things that continues to bother me about the struggle to maintain and grow Zonta membership in the United States is the seeming complacency that American women have regarding their status. Do women have it made in the U.S.? Can we afford to assume that our status is secure? I don't think so.

If women in the U.S. have it so good, why do we still have such a high rate of domestic violence and rape? Why have we not had a woman President or Vice President in the history of this country? and Why aren't more women in politics and leadership positions?

This is the question raised in a recent article in *Parade* magazine. According to this article, today's new generation of politicians are cut from the same cloth as their predecessors: 86% are men, 81% are white, and 29% have a relative who served in office. This lack of progress for women and minorities worries Marie Wilson, president of the White House Project, a nonpartisan organization

that seeks to get more women in leadership roles. Wilson says that the media don't take women politicians seriously. She cites a White House Project study which shows that on *Meet the Press* and other Sunday morning talk shows (which often shape policy), male guests outnumbered women 13 to 1 after 9/11, even though Dianne Feinstein and two other women chaired Senate subcommittees on terrorism. When the media do cover women, the focus tends to be on personal issues, such as appearance; men are more likely to have their positions discussed.

The White House Project is launching "Vote, Run, Lead," to get more women into the voting booth and into public office. You can visit <u>www.voterunlead.org</u> to learn more. Zonta Clubs throughout the United States must grow and take the initiative to help make sure that the status of women in our country does not stagnate, but truly progresses in all arenas, including the crucial political arena.
