Minutes, Saturday, September 24, 2011:

WELCOME

The 60th District 12 Conference opened with the Sweet Adeline's singing for all attendees. Jan Kirch and Kyle Blada, Co-Chairs of the 2011 Conference, welcomed everyone.

CALL TO ORDER

INTERNATIONAL REPRESENTATIVE

Governor Meyer introduced Zonta International District 12 Liaison Kathleen Douglass. Ms. Douglass presented a video message from Zonta International President Dianne Curtis, and presented her own remarks to the Conference participants.

CONFERENCE THEME

Governor Meyer presented the theme for the 2011 District 12 Conference: "Zonta Women of Substance and Style." Ms. Meyer defined the theme as follows: "Substance" is the actual matter of a thing as opposed to its appearance; "substantial" mean of solid character or quality; and "style" being a particular type, a distinctive or characteristic model / manner of being or acting. Together, these themes are woven through the conference as they have been woven through District 12 Zontians for 60 years, and it is starting to be called the "Zonta Brand."

CONFERENCE PROGRAM

Ms. Brada, Conference Co-Chair, presented the Program for the 2011 Conference of District 12, as printed.

MOTION: After hearing no objections, by general consent, the 2011 Conference Program was adopted.

BOARD REPORTS

The District Board members and Committee Chairs presented their reports for the past year.

RECESS FOR DISTRICT 12 SCHOLARSHIP FUNDRAISER

Governor Meyer recessed the business session for the District 12 Scholarship fundraiser together with "Chocolates – Who Knew?!?" – a personality test presented by Nancy Trautman.

Priscilla Romkema, Chair of the Nominating Committee, gave a report regarding District 12 nominations for 2012 – 2014, and opened the Conference for nominations from the floor. Ms. Romkema then presented the candidates forum.

Mary Roth, Conference Teller, provided instructions for voting for candidates. Voting was conducted by the delegates prior to the lunch break.

LUNCH WITH KATHLEEN DOUGLASS

Governor Meyer recessed the business session for lunch with and a presentation by Zonta International District 12 Liaison Kathleen Douglass on Zonta Branding. Mary Roth, Conference Teller, provided instructions for voting for candidates. Voting was conducted by the delegates prior to the lunch break.

TREASURER'S REPORT

Bridget Masters, District 12 Treasurer, presented the Treasurer's Report for 6/1/2010 through 5/31/2011, the Operations Budget Comparison for 6/1/2010 through 5/31/2011; the Compilation of Financial Statements with Accountants Report for the year ended May 31, 2011; and the Approved Operating Budget for 2010-2012. Ms. Masters responded to questions from the delegates.

MOTION: Laura Stamp, Area 4 Director, moved that the Treasurer's Report be adopted as printed and presented. The Motion was seconded by Jo Prang, Area 1 Director. Upon a unanimous vote in the affirmative, the Motion carried.

Ms. Masters then presented the proposed District 12 Budget for 2012 - 2014. Ms. Masters responded to questions from the delegates.

MOTION: Sheila Davis, Lt. Governor, moved that the proposed District 12 Budget for 2012 – 2014 be approved as presented. The Motion was seconded Marcy O'Toole, Area 3 Director. Upon a unanimous vote in the affirmative, the Motion carried.

Nikki Headlee, UN / ZIF Ambassador, gave a brief introduction and explanation of the proposed resolution to amend the Zonta International Bylaws.

MOTION: Janet Bergin, Royal Gorge Club Delegate, moved that the Zonta International Bylaws be amended, as presented to include a Zonta International YWPA Awards Committee. The Motion was seconded by Jo Prang, Area 1 Director. Upon a unanimous vote in the affirmative, the Motion carried.
