All competing artists may submit up to 5 pieces for bin sale (not to be judged) and the price of each piece may not exceed \$100.00. Bin prices must be in even dollar amounts ending in zero, with the name, address, price and media on the back of each matted piece or on the bottom of each piece of 3-D art. All work must be unframed, protected with acetate and marked original or print. Zonta will retain a 30% commission on all sales.

DELIVERY OF ARTWORK

Work must arrive at the Sunflower Bank Building, 531
Main St. in Cañon City on Thursday, October 31, between
4 pm and 7 pm. Shipped works must arrive prepaid in a
reusable container and must include pre-payment for
return shipping including insurance. Ship works to:

RETURN OF ARTWORK

Following the close of the exhibition, entries for return
shipment will be repacked in original container and
shipped. Return shipments will be insured for the sale
price unless otherwise noted. All hand delivered entries
must be picked up on Sunday, November 10 between
noon and 3pm. Artwork not claimed on this day will be
donated to the Zonta Club of the Royal Gorge Region
unless prior arrangements have been made.

PRESENTATION

All entries must be professionally framed or properly
prepared for display. Artwork with clip mounts, missing
wires or sawtooth hangers will not be accepted or hung.
Jewelry and other small work must be in wall-hung or
pedestal locked display cases, including bin items.
Failure to comply will result in work not displayed and
entry fees forfeited.

All submitted artwork must be identified with name, address,
phone number, division, category, title, price or NFS. 2-D
work must be identified on back and 3-D work identified
on bottom with securely attached labels.

SALES

Zonta Club will retain a 30% commission on all sales.

LIABILITY

It is suggested that the artist carry their own insurance.
**All reasonable care will be given to the artwork—
however the Zonta Club of Royal Gorge will not
be responsible for loss or damage, however
caused.** Your signature on the entry form constitutes
