1. Zonta Ladies Night Out – our annual fundraising event. Improves the status of women: We invite Women Owned businesses to have a booth showcasing their products. We ask each of them to put a 'gift basket' valued at \$50 up for raffle. The raffle tickets have demographic information on them so that the women can use them as contacts to build their business. Attendees understand that the business is going to contact them after the event. The majority of the evening is spent shopping at the vendor's booths. We are improving the status of these women by helping them have successful businesses. 100% of club members are involved in this project. 1/3<sup>rd</sup> of the funds raised at this event go to ZIF. Visibility and credibility: We used to be known as those 'antique show women'. We are now known as Zonta! The club that raises money to eliminate violence against women. A portion of the evening, while guests are eating dinner, we provide information regarding Zonta International projects, Zonta of Cheyenne, and eliminating violence against women. 2/3rds of the funds raised will be used to eliminate violence against women. We are guests on the morning TV show talking about Zonta, the event, and what the funds will be used for. Sustainability: This has been an annual event for 10 years. We plan to continue.

2. **Zonta Art Contest** - 2<sup>nd</sup> Annual - we solicited art that represented Human Trafficking. We had 12 artists submit entries. We were on the radio talking about the event, Zonta, and human trafficking. We showcased the art at the Hynds Building, a downtown building with high visibility and known for its art events. We held a reception, all of the artists attended, and many local residents. We also showcased the artwork at our Zonta Ladies Night Out event. Improves the status of women: By raising the level of awareness regarding human trafficking. Many think 'it doesn't happen in my backyard'. 15% of club members were involved in this project Visibility and credibility: We are now known as Zonta! The club that is a resource regarding human trafficking. The TV station came to the reception, taped a segment and we were showcased on the evening news! The local newspaper attended, a reporter and photographer, we were highlighted in the Wyoming Tribune Eagle. Sustainability: we plan to make the contest an annual event. We have barely begun to spread the word regarding human trafficking.

3. Annual Donations - we select entities each December. This year it was SafeHouse, the local shelter for victims of domestic violence. And COMEA the local shelter for the homeless (which has a growing population of women). We found out what they needed and then asked club members to bring donations to the December meeting. We pack up the items and deliver them to Safehouse and COMEA. Improves the status of women: By donating items that women need. Many arrive at the shelter with the clothes on their back and their children's, and little or nothing else. 90% of club members were involved in this project. Visibility and credibility: The executive director of Safehouse is now a member of our club! Sustainability: This has been an annual event for more than 10 years. We plan to continue.

4. Donation of silent auction baskets: This year we donated baskets to events for the following organizations: Lions Club, Comea, Safehouse, Library Foundation. Each basket included information regarding Zonta. Improves the status of women: By donating items we raised the level of awareness of Zonta. Zonta improves the status of women. Each of the organizations has a tie to Women in some fashion. **30% of club** members were involved in this project. Visibility and credibility: We are spreading the word about Zonta! The club that is a resource regarding violence against women. Sustainability: We plan to continue.

5. Collection of Clothes for Julie's Closet: In April and May, we did a clothing drive for a local group that provides professional looking clothing to women in the community in need of appropriate attire for interviews and new jobs. Improves the status of women: By partnering with this existing organization, we assisted women who are trying to get back on their feet and find good jobs so they can support themselves and their families – many of these women are single mothers 25% of club members were involved in this project. Visibility and credibility: We are spreading the word about Zonta! We are also building relationships and partnerships with others in the community who care about helping women. Sustainability: First year project – not clear yet whether this will continue (likely to continue on an "as needed" basis.

For the past two years, Zonta Ladies Night Out proceeds have been accumulated to be used for EVAW initiatives. As a result, we have been invited to be a sponsor and attend the 7<sup>th</sup> Annual Wyoming Crimes Against Children Conference. EVAW will be our primary focus in the upcoming year.

This year the Z Club organized a march from the State Capital to the Laramie County Library. We display the proclamations, information regarding Zonta, the Silent Witness silhouettes and various information at the Laramie County Library for the 16 days. We also display the Silent Witness silhouettes at City Hall and the Federal Building. Improves the status of women: Educational - By raising the level of awareness regarding violence against women. The project. Partners: Safehouse, Governor of Wyoming and Mayor of Cheyenne, Triumph Z Club, Laramie County Library, City Hall, Rutgers, Cheyenne Police Department. Visibility and credibility: We are now known as Zonta! The club that is a resource regarding violence against women. City Council person Dicky Shanor made a speech and presented the proclamation signed by Cheyenne Mayor Kaysen. Z Club sponsor JoLynn Murphy made a speech that included domestic violence statistics for the State of Wyoming and the US. The silhouettes remained on display from November 23<sup>rd</sup> to December 10th at Laramie County Library, 2200 Pioneer Ave., as well as at the Cheyenne Municipal Building at 2101 O'Neil Ave., the Joseph C. ## NEW: Triumph students march for domestic violence awareness

CHEYENNE (WTE) - A group of students from Triumph High School's Z Club marched from the Wyoming State Capitol to the Laramie County Library this morning in recognition of domestic violence victims in the state.

Each student carried a silhouette representing a victim of domestic violence who died at the hands of an abuser. Following today's march, the silhouettes will be put on display at several locations around town.

Prior to the march, Wyoming Gov. Matt Mead signed a proclamation acknowledging the Z Club's efforts in connection with Zonta International's 16 Days of Activism against gender violence, which runs from Nov. 25 to Dec. 10. Founded in 1919, Zonta International's mission is to advance the status of women worldwide, with domestic violence one of the service organization's key focuses.

## Three Proclamations signed by Gov. Mead today

Governor Matt Mead was scheduled to sign three proclamations in the Formal Office today.

Gov. Mead signed the Proclamation for 16 days of Activism Against Gender Violence, the Proclamation for Homeless Children and Youth Awareness Month, and the Proclamation for Diabetes Awareness Month.

Proclamations are issued by the Governor to honor and celebrate events, recognize achievements or increase public awareness of noteworthy causes. Requests are reviewed on a case-by-case basis and are honored at the Governor's discretion and subject to the guidelines of this Policy, according to the Proclamation Policy.

CHEYENNE - A group of students from Cheyenne's Triumph High marched in silence Monday morning from the State Capitol to the Laramie County Library.

Each carried a silhouette with them - more than three dozen in all - each representing a victim of domestic violence in Wyoming.

Their stories differed from one person to the next, but they all had the specter of domestic violence in common. There was Sharon Johnson, who was 43 when her husband ran her over with his car, leaving their two children without a mother.

There was Robin Munis, age 40, who was singing on stage at Old Chicago in Cheyenne when her estranged husband shot and killed her with a sniper rifle.

And there was Crystal Town, 29, whose husband was sent to prison for 75 years to life last year for shooting her in front of their 10-year-old daughter.

"We grieve for the family that lost the loved one. But beyond that, you grieve for the opportunity lost," said Gov. Matt Mead, who signed a proclamation Monday recognizing 16 days of activism against gender violence in Wyoming from Nov. 25 to Dec. 10.

Those dates are not coincidental: Nov. 25 is the International Day to Eliminate Violence Against Women, while Dec. 10 is International Human Rights Day. But since the Triumph students knew they would be out of school by the 25th, they opted to hold their march two days earlier to publicly honor victims like Town.

"Consider Crystal, who and what she could've become, what she could've contributed," Mead said, turning to the students. "We all have a role to play, but the most important role lies on your shoulders. It is you all, your leadership, that is going to provide the answer that says, 'In Wyoming ... there's no instance where domestic violence is acceptable."

Monday's marchers were mostly members of Triumph's Z Club, a youth spinoff of Zonta International, an Illinois-based service organization that seeks to advance the status of women across the globe. And like the silhouettes they held, many of Monday's marchers said they were similarly affected by domestic violence.

"This is close to my heart because I was abused by my father, and so was my mother," said Triumph senior Madison Amann. "So it carries a lot of significance

personally to me, and it brings awareness and advocacy to other people."

Another senior, Jessica Kling, said she joined the Z Club after watching her father abuse one of her brothers.

"There was one case where he put his tooth through his lip and continued to hit him in the back and throw him through things," Kling said. "That's the main reason I wanted to join Z Club, because it's not right for people to have to go through those things."

Kling said that, too often, domestic violence is swept under the rug, with victims unwilling or unable to confront it or tell their stories. She said that imposed silence makes it doubly important for advocates to provide a voice for victims.

"It doesn't make headlines like it should," Kling said. "This is showing people that it really happens; it's not just some story."

Jolynn Murphy, a co-adviser for the Triumph Z Club, read off some of the state's domestic violence statistics, noting that 66 women, seven men, four minor boys and one girl have died since 1985 as a result of domestic violence in Wyoming.

"Domestic violence doesn't just affect victims and perpetrators; it affects the family and friends who are left behind," Murphy said. "The problem will continue until we as a society and a community stand up with one resounding voice and say, 'No more!'"

Cheyenne City Councilman Dicky Shanor also took part in Monday's march. Having worked as a domestic violence prosecutor for Laramie County, Shanor questioned why there hasn't been more awareness directed toward the issue in recent years.

"It's very prevalent still - hundreds and hundreds of files funnel through the district attorney's office in our county every year," Shanor said. "I just want to say thank you to all of you for doing this, for raising awareness around this issue."

Murphy noted that several of the silhouettes used in Monday's march will remain on display through Dec. 10. They can be seen at the Laramie County Library, 2200 Pioneer Ave., as well as at the Cheyenne Municipal Building at 2101 O'Neil Ave., the Joseph C. O'Mahoney Federal Building at 2120 Capitol Ave., and Grace United Methodist Church, 2950 Spruce Drive.

Local musician Ty Warner concluded Monday's march with a song he wrote in honor of Munis, whom he shared a stage with the night she was killed in July 2007.

"A shot rings out, and a soul is dashed; a pool of life, and a song is past," Warner sang. "Tried to reason why, but reason won't return. And it happens in the blink of an eye."

The luminary bags are displayed in windows and outside of homes on November 25<sup>th</sup> during the 16 days of Activism.

#### **Other Advocacy questions:**

What women's issues have been identified as the most important in your club? Ending Violence Against Women We have begun the research to determine the gaps that exist in Laramie County as part of our Eliminating Violence Against Women (EVAW) initiative. Club members have met with a pre-determined list of people/entities in the county with a specific list of questions. Our goal is to learn what is already being done, get Zonta invited to the table when entities come together, and develop relationships with like-minded organizations. For the past two years, Zonta Ladies Night Out proceeds have been accumulated to be used for EVAW initiatives. As a result, we have been invited to be a sponsor and attend the 7<sup>th</sup> Annual Wyoming Crimes Against Children Conference. EVAW will be our primary focus in the upcoming year.

How have club members been made aware of legislation relevant to women in our country? Yes, we share the Wyoming Women's Foundation Newsletter throughout the Legislative session, we've invited Lobbyists and legislators to our meetings to provide information in the past as well.

#### History of the UN/Zonta Connection

#### 2014-2016 Biennium Projects

Working Toward an HIV-Free Generation and Effective Prevention and Response to Gender Based Violence in Rwanda.

Overall Objective To contribute to a nation free of AIDS and new HIV infection among children, adolescents, women and families; to support the national scale-up strategy for One Stop Centers; and to invest in community based prevention of violence against women and children. Since 2008, ZI has provided a total of 2.2 million USD to support this project. 89% of health facilities offer prevention of mother to child transmission services and 62% of HIV+ pregnant women received antiretroviral treatment during pregnancy. More than 6,000 survivors of violence were treated at the Isange and Rusizi One Stop Centers

#### Ms. Heather Wilkins

Vietnam, Gender Responsive Schools Pilot Model.

Overall Objective To create a school environment for adolescent girls and boys across Hanoi that is free from gender-based violence. Background Gender-based violence in and around schools is highly prevalent in Vietnam and is one of the main barriers to girls' empowerment and gender equality. Plan Vietnam, a UN Trust Fund grantee, will promote a model of safe, accountable and child-friendly schools where adolescent girls and boys receive a quality education in an environment free of gender-based violence.

#### Ms. Robin Kus

Towards Elimination of Obstetric Fistula and Reduction of Maternal and Newborn Mortality and Morbidity.

Overall Objective To improve the health and socio-economic status of women and young girls within Liberia. Since 2008, Zl has provided a total of 1.95 million USD to support this project. A total of 1,079 women and adolescent girls with various types of fistulae have received surgical treatment. A total of 264 survivors have been rehabilitated and reintegrated into their mainstream communities.

#### Ms. Lisa Hunt

Safe Cities for Women Project in Guatemala City, Guatemala and San Salvador, El Salvador.

In Guatemala and El Salvador, rates of urban violence and violent homicides are above the already high regional average and women are at an even greater risk of violence due to the traditionally subordinate position of women in society. During the first phase of the project, significant results were achieved in both Guatemala and El Salvador. In Guatemala, women's organizations submitted proposals to local authorities to improve public spaces and identified insecure spaces which led to the transformation of an abandoned house to a day shelter for people living with HIV/AIDS. In El Salvador, a map of unsafe places determined by the perceptions of local women was presented to the local authorities who are committed to implementing recommendations to make these areas safer for women. For the next phase of the project, efforts will be focused on increasing visibility and impact by disseminating information on violence against women in the most violence districts of both cities and replicating the experience in all districts of the capital cities. The project will also expand to incorporate the issue of violence against women in the context of HIV/AIDS.

## Zonta International Advocacy

Zonta International advocates to promote the human rights of women at international, national and local levels. Zonta advocacy aims to influence the making and implementation of laws, as well as general attitudes and behaviors. Zonta advocacy promotes real equality, not formal equality alone. Zonta seeks to take fact-based actions, to highlight root causes of problems and to present solutions with proven results.

- Accredited Representative (on application) to Working Group Sessions of the Human Rights Council (now Commission) via consultative status with ECOSOC (Geneva).

Zonta International has **participatory status with the Council of Europe**, which enables Zonta to actively contribute to its work. At the international level, Zonta supports the efforts of the United Nations and its Members States to empower women through the adoption and fulfillment of international conventions and treaties. Zonta's international committees give recommendations to the Zonta International Board on advocacy actions. Members of the International United Nations Committee represent Zonta International in NGO Forums in New York, Geneva, Vienna and Paris. Members of the Council of Europe sub-committee represent Zonta International in relation to the Council of Europe. Members of the International Advocacy Committee assist in formulating advocacy statements on international issues. For its International Service and ZISVAW programs, Zonta International looks for projects that include specific advocacy goals. International committees also alert members to opportunities for advocacy at national and local levels. Members are encouraged to study their country reports to CEDAW as well as reports to UN entities on BPfA and MDG progress to look for opportunities for advocacy actions. The submission of NGO reports on Country reports is also encouraged, thus engaging members in matters which are pertinent to national as well as international issues.

#### 1. School Service

School service consists of projects or programs that benefit the school that sponsors the Z club or Golden Z club. In the case of off-campus Z clubs or Golden Z clubs, programs or projects that directly benefit the sponsoring Zonta club may apply.

Examples of school service:

- Hosting an international fair that focuses on the role that women play in different countries to teach
  others about different cultures and the status of women internationally;
- · Establishing a tutoring network for the school or university;
- Creating a Z club program table at a school orientation night for incoming students to raise awareness of the Z club program and Zonta International.

#### 2. Community Service

Community service consists of projects or programs that benefit the local community where the Z club or Golden Z club is located.

Examples of community service:

- Enlisting the expertise and network of the sponsoring Zonta club to host a reception for women candidates for public office in the community;
- Volunteering for a community literacy program to read to children or to assist adults to learn to read;
- Hosting a fund raising event or donating resources (time, money, material goods) to contribute to a local charity, crisis center, or special project of the sponsoring Zonta club.

#### 3. International Service

International service is service that benefits an international organization, international cause or an international community other than the one where the Z club or Golden Z club is located. International service may be a project that raises funds or resources for an international organization, such as UNFPA, UNICEF or UN Women, or contributing to one of Zonta International's designated international service projects.

Examples of International Service:

- Raising awareness for the United Nations by hosting a United Nations Day celebration on 24 October;
- · Raising awareness of international advocacy for women's rights;
- Hosting a unique fund raising project and donating the proceeds to a project for women that Zonta International and a UN agency co-sponsor during a biennium.
