

# What is Advocacy?

Act or process of supporting a cause or proposal



Public support for an idea, plan or way of doing things



Under these definitions, all Zontians are advocates – just to different degrees.

# How to Begin

- Pick an issue you care about
  - What are you passionate about?
  - What are you willing to spend time and energy on to effectuate change?
- Gain a thorough understanding of the issue
  - Know the facts (information is power)
    - A few solid facts can make a difference
    - Take a few of these facts and have an elevator speech ready
  - Understand the opposition's arguments
- Set a goal (Goal should facilitate change)
  - What is the desired result of any advocacy activity?
  - Best to have a proposed solution to the identified problem or issue

# Raise Awareness and Educate Others

- Leverage your experiences
  - Share your experiences and what you learned (good or bad)
  - Use these experiences to emphasize the point you are trying to make
- Know your audience (will impact style and message)
  - How much do they already understand?
  - Are you trying to fire them up or trying to teach them about the issue?
  - Are you trying to influence a policymaker?

# **Engaging Others**

- Find someone to champion (or help champion) your cause
  - Prominent person in community
  - Person with influence
  - An unknown who is a bulldog who is willing to lead the charge
- Partner with like-minded people or organizations
  - Different folks bring different life experiences
  - Different spheres of influence
  - Power in numbers
- May partner with different groups or people on different projects
- Consider engaging men especially in the projects of ending violence against women

   there are a lot of men's groups these days addressing "toxic masculinity"

- Workshops
- Speeches
- Radio Call-in Programs
- Posters
- Pamphlets

- Billboards
- Letters to the Editor
- Demonstrations / Marches
- Drafting Legislation
- Testifying before Policymakers

  - Does it seek to promote justice and universal respect for human rights and freedom?

# Be Persistent

- Things don't change overnight
  - Think of your advocacy as a long-run project (marathon, not a race)
- Build upon prior success and learn from failures

#### HELP END CHILD MARRIAGE: KEEP GIRLS IN SCHOOL

The economic benefits of girls' education are substantial and can help lift households, communities and nations out of poverty. Keeping girls in secondary school could:

- Add \$92 billion to the economies of low and middle-income nations;
- Cut child deaths by 50 percent;
- Reduce child marriage by 66 percent;
- Decrease violent conflict by 37 percent; and
- Increase girls' future wages by up to 20 percent for every year enrolled.
